# <u>Clinical Laser Program 16 weeks On-site 640 hours total hours (390 hrs theory On-site, 250 hrs practical theory)</u>

## Bacteriology, Hygiene, Sterilization and Rules and Regulations (16 hours) - Day 1 &2
